2022 Water Quality Report for Lake Hemet Municipal Water District

We test the drinking water for many constituents as required by state and federal regulations. This report shows the results of our monitoring for the period of January 1-December 31, 2022, and may include earlier data.

There are ten wells located along the San Jacinto River from Valle Vista to San Jacinto that supply most of your drinking water. Complete drinking water source assessments (2002, 2014, 2022) for all ten wells and our 2017 Sanitary Survey are available upon request at our district office located at 26385 Fairview Ave. Hemet, CA 92544 (951-658-3241) or from the State Water Resources Control Board, Drinking Water Field Office, 2375 Northside Drive, Suite 100, San Diego, CA 92108 (619-525-4159). The assessments determined our sources are most vulnerable to sewer collection systems, septic systems, agricultural and/or irrigation wells, and high-density housing.

Lake Hemet MWD treats all its ground water sources with chlorine disinfectant, either in liquid or tablet form. This is the only treatment added to the water we provide. There are 2 tie-ins to EMWD water, which also comes from local ground water sources and is treated similarly. In 2022, 2.46% of domestic demand was purchased from Eastern Municipal Water District (EMWD).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno- compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. USEPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (1-800-426-4791).

Nitrate in drinking water at levels above 10 mg/L is a health risk for infants of less than six months of age. Such nitrate levels in drinking water can interfere with the capacity of the infant's blood to carry oxygen, resulting in a serious illness; symptoms include shortness of breath and blueness of skin. Nitrate levels above 10 mg/L may also affect the ability of the blood to carry oxygen in other individuals, such as pregnant women and those with certain specific enzyme deficiencies. If you are caring for an infant, or you are pregnant, you should ask advice from your health care provider. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. LHMWD is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. While your drinking water meets the federal and state standard for arsenic, it does contain low levels of arsenic. The U.S. Environmental Protection Agency continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.

To ensure that tap water is safe to drink, the USEPA and the State Board prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The U.S. Food and Drug Administration regulations and California Law also establish limits for contaminants in bottles water that provide the same protection for public health. In June 2022, We had an E.coli-positive sample, following a total coliform-positive routine sample.

E. coli are bacteria whose presence indicates that the water may be contaminated with human and animal wastes. Human pathogens in these wastes can cause short-term effects, such as diarrhea cramps, nausea, headaches, or other symptoms. They may pose a greater risk for infants, young children, the elderly, and people with severely compromised immune systems. We found E. coli bacteria, indicating the need to look for potential problems in water treatment or distribution. When this occurs, we are required to conduct assessments, identify problems and to correct any problems that were found during these assessments. We were required to complete a Level 2 assessment because we found E. coli in our water system. In addition, we were required to take 4 corrective actions and we completed 4 of these actions.
