We test the drinking water quality for many constituents as required by state and federal regulations. This report shows the results of our monitoring for the period of January 1 -December 31, 2016 and may include earlier monitoring data.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

THE USEPA AND THE STATE WATER RESOURCES CONTROL BOARD (STATE BOARD) PRESCRIBE REGULATIONS THAT LIMIT THE AMOUNT OF CERTAIN CONTAMINANTS IN WATER PROVIDED BY PUBLIC WATER SYSTEMS. STATE BOARD REGULATIONS ALSO ESTABLISH LIMITS FOR CONTAMINANTS IN BOTTLED WATER THAT PROVIDE THE SAME PROTECTION FOR PUBLIC HEALTH.

The following tables list all the drinking water contaminants that were detected during the most recent sampling. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. The State Board allows us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of the data, though representative of the water quality, are more than one year old.

#### Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria that may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

Inorganic contaminants, such as salts and metals, that can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil chemicals that are by-prod and gas production, mining, or of industrial processes and farming. petroleum production, and

#### **Pesticides and herbicides**

that may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals that are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, agricultural applications and septic systems.

**Radioactive contaminants** that can be naturally-occurring or be the result of oil and gas production and mining activities.

## Terms used in this report

Maximum Residual Disinfection Level Maximum Contaminant Level (MCL): the **Goal** (MRDLG): The level of a drinking highest level of a contaminant that is allowed in water disinfectant below which there is no drinking water. **Primary Drinking Water Standards** (PDWS): MCLs and MRDLs for contaminants that affect health along with their monitoring an reporting requirements, and water treatment requirements. **Secondary Drinking Water Standards** (SDWS): MCLs for contaminants that affect taste, odor or appearance of the drinking water. Contaminants with SDWSs do not affect health at the MCL levels. Treatment Technique (TT): a required process intended to reduce the level of a contaminant in drinking water.

**Regulatory Action Level** (AL):the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

Variances and Exemptions: State Board permission to exceed an MCL or not comply with a treatment technique under certain conditions.

Level 1 Assessment: a Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

Level 2 Assessment: A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E.coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions. ND: not detectable at testing limit **ppm:** parts per million or milligrams per liter (mg/L) ppb: parts per billion or micrograms per liter ( $\mu$ g/L) **ppt:** parts per trillion or nanograms per liter (ng/L)ppq: parts per quadrillion or picograms per liter (pg/L) pCi/L: picocuries per liter (a measure of radiation) **µS/cm:** microsiemens per centimeter (a measure of conductivity)

## **Additional General Information on Drinking Water**

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Lake Hemet MWD is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you do so, you may want to collect the flushed water and reuse it for another beneficial purpose, such as watering plants. If you are concerned about lead in your water, you may wish to have your water tested.
