

**RESOLUTION NO. 819**

**RESOLUTION OF THE BOARD OF DIRECTORS OF  
LAKE HEMET MUNICIPAL WATER DISTRICT  
ESTABLISHING THE APPROPRIATIONS LIMIT  
FOR FISCAL YEAR 2025-2026**

**WHEREAS**, ARTICLE XIII B of the California Constitution places an annual limitation upon appropriations from proceeds of taxes by each government of the State of California; and

**WHEREAS**, Section 7910 of the California Government Code implements Article XIII B of the California Constitution by requiring each local jurisdiction to annually establish, by resolution, its appropriations limit for each fiscal year, beginning in 1980-81, and to make the documentation used in determining the appropriations limit available to the public 15 days prior to adoption of the resolution establishing the appropriations limit; and

**WHEREAS**, California voters approved Proposition III that made certain revisions to Article XIII B in 1990, which require the Board of Directors to select the annual adjustment inflation factor and the population adjustment factor, therefore this Board had determined that this District would choose:


1. The growth in the California Per Capita Income (provided by the State Department of Finance the personal income change is 6.44%), and
2. The change in population within the county in which the public entity is located (provided by Department of Finance for Riverside County the percentage is +0.20 between January 1, 2024 and January 1, 2025).

**WHEREAS**, this District has documented its calculation of the District's appropriations limit for fiscal year 2025-2026 and said calculation was posted by the District and made available to the public since May 29, 2025.

**NOW, THEREFORE, BE IT RESOLVED** BY THE Board of Directors of Lake Hemet Municipal Water District as follows:

1. The appropriations limit applicable to this District pursuant to Article XIII B of the California Constitution for fiscal year 2025-2026 is hereby established and determined to be the sum of \$15,800,252.40.
2. A copy of the documentation used in the determination of the 2025-2026 appropriations limit shall be affixed hereto and will be available for public inspection.
3. Pursuant to Section 7910 of the California Government Code any judicial action or proceeding to attack, review, set aside, void or annul the establishment of the 2025-2026 appropriations limit as set forth herein must be commenced within 60 days of the adoption of this resolution.

## LAKE HEMET MUNICIPAL WATER DISTRICT

The Board of Directors of Lake Hemet Municipal Water District will adopt a Resolution setting the Appropriations Limit for Fiscal Year 2025/2026 at the Regular Board meeting to be held Thursday, June 19, 2025 at 3:00 p.m. Calculations made to establish the Appropriations Limit follow:

### 2025 – 2026 Limit

**California per capita personal income change:** **6.44 percent \***  
(\* = Cost-of-Living price factor provided by Dept of Finance per capita personal income.)

California per capita personal income converted to a ratio:

$$\frac{6.44}{100} + \frac{100}{100} = 1.064 \text{ percent}$$

**Riverside County population change (01/01/24 – 01/01/25):** **0.20 percent**

Population change converted to a ratio:

$$\frac{0.20}{100} + \frac{100}{100} = 1.002$$

$$\text{Ratio of change: } 1.002 \times 1.064 = 1.066$$

Appropriations Limit for 2023 – 2024 was: **\$14,822,000.40**

$$\underline{\$14,822,000.40 \times 1.066 = \$15,800,252.40}$$

**Appropriations Limit for 2025 - 2026: **\$15,800,252.40****
